| Summary | All current University of Phoenix degree students who are actively enrolled in a University of Phoenix master's degree program who (i) have taken a minimum of 9 credits at the University of Phoenix and have at least 9 credits remaining in a University of Phoenix master's degree program; (ii) have an aggregate GPA of 3.85 or higher (on a 4.0 scale) in their current master's degree program; (iii) have not had an unapproved break in attendance greater than 14 days in the last 365 days except for an approved leave of absence as of the scholarship deadline; and apply for this Academic Achievement Master's Scholarship (Current Students) – January 2023 ("Scholarship") prior to the deadline and post attendance in a class between January 1 st , 2023 and January 31 st , 2023 ("Initial Attendance Window") will have the opportunity to be considered for one of fifteen (15) scholarships up to \$2,000 each. |

Selection Process

1. The recipients of the scholarships will be selected by the University of Phoenix.
2. It is the applicant's responsibility to submit a complete and signed application along with any required and supporting documentation, which must be received on or before the Application Deadline. The University of Phoenix accepts no responsibility for incomplete applications, applications not in proper form, lost applications, or any other submission in exception to the instructions.
3. Scholarship selection shall be made without regard to race, color, religion, sex, sexual orientation, gender identity, age, national origin, disability, veteran status, or any other category protected by federal, state, or local law.
4. The 15 scholarships will be awarded to the eligible applicants with the highest GPA that apply by the application deadline. In the event there are applicants with the same GPA, the applicant(s) with the earliest date of application will receive the scholarship.

Scholarship Award
Distribution and
Timing

The University of Phoenix will determine and notify the recipients of the scholarships upon validation.

1. The maximum Scholarship award is \$2,000. The Scholarship shall be disbursed as a credit toward the student's tuition payments at a rate of \$185 per course until: (i) the student completes 10 courses, after which a final disbursement of \$150 will be applied toward the eleventh course, thus maximizing the \$2,000 total Scholarship amount, or (ii) two years has elapsed from the student's first date of attendance in the their first course, or (iii) the student graduates from their program, whichever comes first. Subsections (i)-(iii) are collectively hereinafter referred to as "Terminating Events".
