Applicant must successfully pass each course attempted in accordance with their program's requirements as outlined in the academic catalog for all courses. Any withdrawals or courses not successfully passed in accordance with the program requirements will terminate the scholarship. 3. Applicant must maintain a cumulative GPA of 3.0 or better for all courses. 4. Applicant may not have an unapproved attendance gap greater than 35 days.
